If you are looking for a residential property and you have not given instructions to the NVM estate agent for this, the following situations are possible:

- You want to be kept informed of the properties listed via the NVM estate agent without obligation. See 8
- You want to own your own broker or visit ownership or rental offered by the estate agent. See 5.
- You want to own or through your own broker to buy a property that is offered through the estate agent. See 6.
- You want to own or through your own broker to rent a house that is offered by the estate agent. See 7.

## In commercial buildings, agriculture and real estate:

You want to sell your commercial or agricultural property, rent or let value and shall also instruct the estate agent / appraiser:

- You want to sell your commercial or agricultural property. See 10.
- You want to rent your commercial or agricultural property. See 11.
- You want to value a commercial or agricultural property. See 9.

You want to buy or rent a commercial or agricultural property and shall also instruct the estate agent:

- You want to buy a commercial or agricultural property. See 12.
- You want to rent a commercial or agricultural property. See 13.

If you are looking for a commercial or agricultural property and you have not previously the estate agent through a command mode, the following situations are possible:

- You want to be free of obligation kept informed of the offer by the estate agent. See 8.
- You want to own your own broker or a commercial or agricultural property for sale or rent see what is offered by the estate agent. See 5.
- You want to own or through your own broker to buy a commercial or agricultural property which is offered through the estate agent. *See 14*.
- You want to own or through your own broker to rent a commercial or agricultural property which is offered through the estate agent. *See 15*.

## Data transmission to the NVM

- creates a database that can be used to create valuation reports, and to spot trends in the residential housing market, commercial real estate market and agricultural holdings market. The data in this database is kept for an indefinite period of time.

# We take your privacy seriously

The estate agent and the NVM take your privacy very seriously and see the rules concerning data protection as a good and logical development measure. The estate agent will process your data carefully and in accordance with the requirements of the legislation. The estate agent pays great attention to adequate security so your data is protected from unauthorized use, unauthorized access, alteration and unlawful destruction. All NVM brokers continue to invest in providing good services. Part of this is the NVM-wide privacy program. If you have questions, do not hesitate to contact the estate agent.

### Consult, modify or delete data

Want to know what information the estate agent for you, please send a letter or e-mail your request to the broker. NVM use any names or other identifying data immediately. If you want to know which processes data NVM, please also contact the estate agent which then allows you updated.

If you want to change or erase the data, send a motivation letter or email to the estate agent. Your request will be granted as quickly as possible, unless required by law to retain the data, or if there are (other) compelling reasons to resist change or deletion.

## How can you complain?

If you have questions or if you have a complaint about the data usage of the estate agent, please contact the estate agent. If you do not come with the estate agent, you can contact the complaints coordinator of the NVM by: secretariaatCL@nvm.nl. In that situation will NVM Officer Computing examine the complaint. You also have the right to file a complaint with the Authority for Personal Data.

# How long does the estate agent the data?

The estate agent stores the information longer than necessary. Some data, however, retain the estate agent lengthy:

- Some details of the service keeps the estate agent for 20 years, since the estate agent can be held responsible during this period for professional misconduct.
- The burden of proof that the estate agent the compulsory test under the Act on Prevention of Money Laundering and Financing of Terrorism (Wwft) has carried out the estate agent saves five years.

#### Data usage by the NVM

provide the estate agent through a link certain information to the NVM. NVM is the received data processors responsible. The NVM do the following with this information:

- 1. Ensure all NVM brokers have a current range of residential, commercial and agricultural property which or which are or will be offered through NVM brokers.
- 2. Ensure that the current range is set on foundations and other (houses) websites.
- 3. Provide a database through which appraisals and other value determinations and insights can be built up on the developments in the housing market, commercial real estate market and the agricultural property.

# A Current supply houses, business premises in NVM brokers

If you want to sell a home, business premises through an estate agent will be announced the following information to other NVM estate agents:

- The address of the residential property, the commercial premises or the agricultural holdings, the description and characteristics of the property such as the asking price, the year of construction, the surface areas and layout, data held with the Land Registry, municipality-assessed value of the property for the purpose of calculating local property tax and photographs of the property.
- Date when the property came onto the market, date when the property was taken off the market. Sale subject to change, sale date and transaction price.

These data are used by NVM estate agents for the services they provide to their customers (people who are searching for a residential property, commercial premises or agricultural holdings). This data is stored indefinitely in connection with the database on which historical listings are saved; see under C.

### B Actual offer residential, commercial at (houses) websites, including foundations

If you want to sell a house, an office building through an estate agent will be after consultation with also data published by foundations and other (houses) websites. This involves the following:

- The address of the home, commercial or agricultural property, the definition and characteristics of the object as the asking price, year of construction, the surfaces and layout, cadastral data, real-property value and photos of the object.
- Date that the object comes on the market of sale.

With this information, your object brought to the attention of consumers, professionals and / or third parties find themselves on (home) websites. You enter through your estate agent permission or not to do so.

This data may up to one year after the purchase date or the date a home, business or agricultural real estate market is taken are still visible on these websites.

#### C database with historical demand

of all residential, commercial and agricultural property sold through an estate agent, the following information is recorded in the NVM database:

- The address of the home, commercial or agricultural property, the definition and characteristics of the object as the asking price, year of construction, the surfaces and layout, cadastral data, real-property value and photos of the object.
- Date that the object reaches the market, the date of the market object is removed. Sale subject, date of sale and transaction price.
- Postcode (1234AB) from the previous (home) address of the buyer.

The above information is stored indefinitely.

With the aforementioned data enables NVM analyzes of the housing as possible. The NVM provides this information to selected third parties, namely:

- Appraisers, for doing appraisals and other valuations.
- Validation institutes, to check valuations.
- Municipalities, for the determination of real-property values.
- The Ministry of Infrastructure and Water, for research into the housing market.
- Universities, for research purposes.
- NVM estate agents in the context of service to their customers.
- Not NVM brokers, banks, property developers and housing, for research purposes (eg. Housing demand in a particular region).

These parties only have access to data for the stated purposes and, where possible, data is provided only on an aggregate level.
